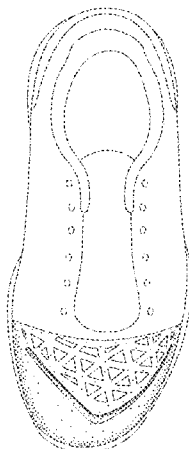
(57) **CLAIM**

The ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe upper showing my new design;
 FIG. 2 is a lateral side view thereof;
 FIG. 3 is a medial side view thereof; and,
 FIG. 4 is a top view thereof.
 The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The 25 unshaded polygonal regions within the shaded area form no part of the claimed design. The broken lines showing the remainder of the shoe are for environmental purposes only and form no part of the claimed design.

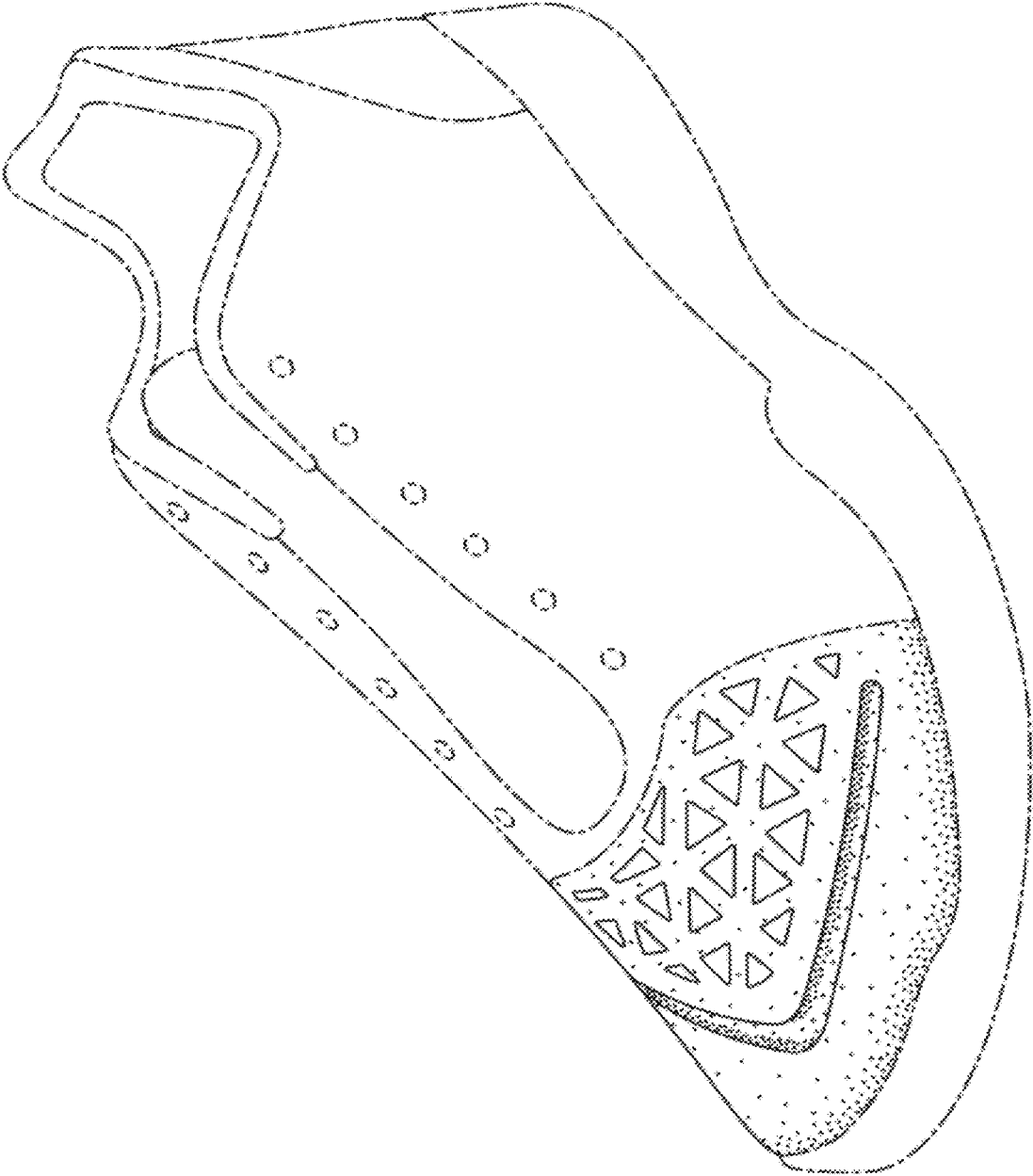

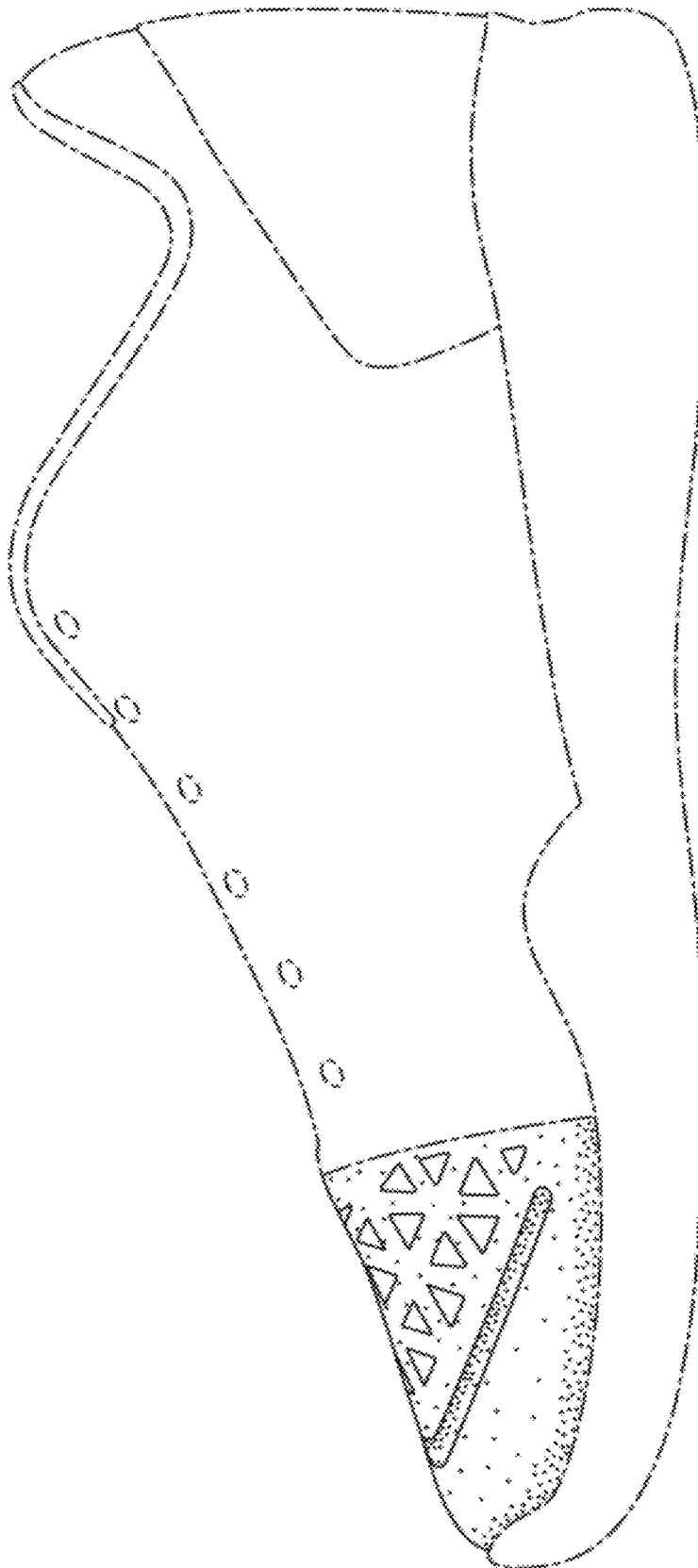

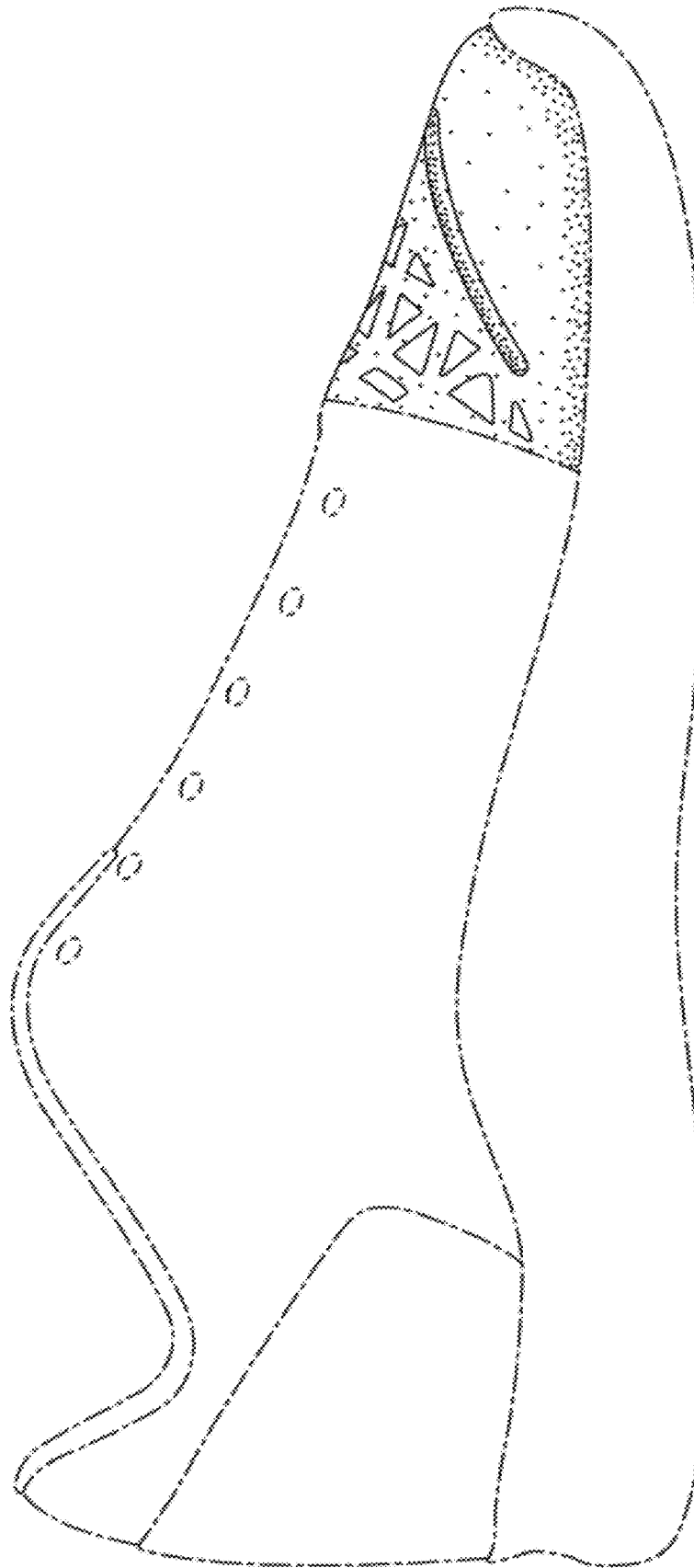

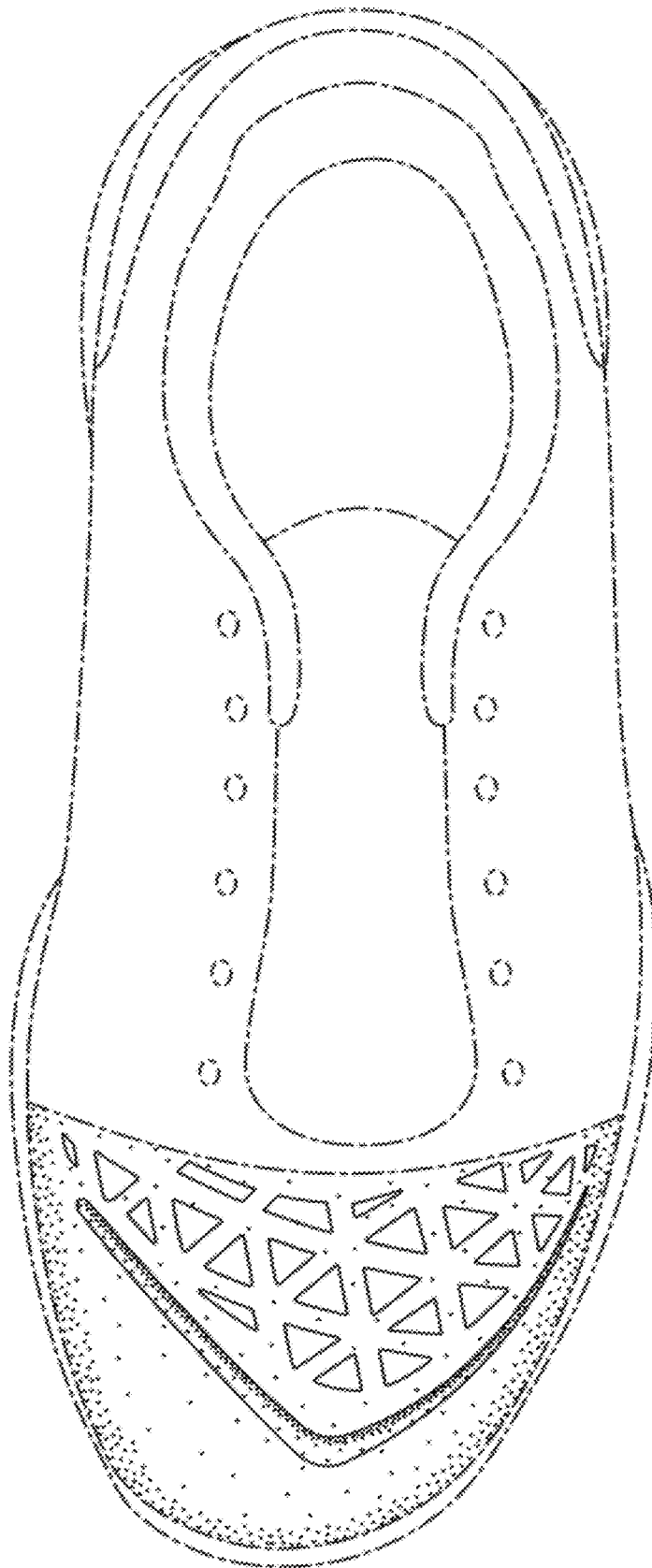
